New Locomotive Purchase!

As our private and public events have become more popular and ridership has increased, this has created a need to purchase a new and reliable gas powered 6-axle locomotive to keep up with the demand of our operations. Our search has been narrowed down to the SD40 or SD45 offered by Titan Trains and the SD40T-2 or SD45 offered by The Train Works. Our Dash-9 from Titan Trains has been the backbone and go-to for all of our events since August, 2018, and has shown time and time again to be a very user friendly, safe, and an overall reliable locomotive. The additional 6-axel locomotive will work alongside the Dash-9 to provide more reliable and enjoyable train trips for all who visit our railroad, and serve as an additional as well as alternate go-to locomotive for private events.

The Board of Directors is asking our General Membership to get involved in the decision-making process. A final decision on how to proceed will be made at the General Membership meeting at the Fall Meet, the evening of October 18th.

The items to be determined are as follows: **<u>Titan Trains</u>**

SD40-2 - \$19,695 Paint-\$1000-\$3000Snow Plow-\$255 SD45 - \$19,695 Shipping and Crating - \$1,428 *Will provide 10% Discount on Final Purchase Cost

The Train Works

SD40T-2 - \$20,998 Primer-\$300 Paint-\$1200-\$1600 Snow Plow-\$250

SD45 - \$20,278 *Will take \$1000 off Purchase Cost and Include Delivery

The research that has been conducted includes the past experiences of three Live Steam organizations that have generously provided information on their operations, and how the locomotives from both companies have benefited their railroad. While a discussion will continue to be held by the General Membership, it is recommended by the Board of Directors that the purchase for a new 6-axle locomotive be made through Titan Trains.

10 Years ago: Special thanks goes to Rob Sharratt for spending all day digging to find a broken pipe on our main irrigation water lines. It had been leaking for a while as it was noticed that the ground was getting softer and finally standing water.



20 Years ago: Following the Hot August Nights event, vandals destroyed about thirty feet of dual gauge track just outside of the fence in the old loop. By the time you read this, it should be fixed by our track workers. This brings up the subject of security at the track. The Board has agreed that it is time to change the locks at the facility. Of course, some of our track is outside of the fence but much of our track and property is inside. The last time we were vandalized, it was inside.

40 Years ago: Largest work party in history! There were 32 SVLS members and kids, and 32 members of the Sheriff's weekend work project. There was a tremendous amount of work accomplished. The area for the Maintenance shed was cleared, post holes dug and posts cemented in place. The switch for new siding yard was installed, 6 new trees were planted, a broken pipe repaired, and the entire area was mowed.

50 Years ago: TDon Sprenger (Track Foreman) constructed a new weed killer car. It has a tank and motorized pump and was designed to keep the right of way clear of those unwanted growths with a minimum of mess.



SAFETY RULES FOR THE MONTH

1.08 Mode of seating

Passengers must remain seated, straddling seat, and facing forward, on the cars at all times until the train returns to the station. Arms and legs must be kept inside the cars at all times while the train is in motion.

2.02 Daylight Operations

All Locomotives shall be equipped with a whistle, horn, or other sounding device producing audible signals. Such sounding devices shall be powerful enough to be heard distinctly for at least 150 feet. All locomotives shall carry a red flag and whistle to warn traffic of emergencies and for passing on visual and audible signals

3.19 Bad Order Cards

Equipment that is taken out of service shall be tagged for cause. Tagged equipment must not be operated or coupled to any engines or cars except for repairs or corrections. The bad order card shall not be removed until repair is fixed.

4.04 Responsibilities of Stationmaster

The Stationmaster will have complete charge of the Station. The Stationmaster shall have a whistle (police type), red flag, and flashlight in their possession at all times while acting as a Stationmaster. They shall supervise the loading and unloading of all passengers at the passenger station. They shall discreetly refuse passage to passengers who obviously cannot fit or sit safely on a passenger hauling car. They shall make certain that all passengers have been advised and understand the safety instructions before the train leaves the station. They shall work in close cooperation with other operating personnel to keep passenger-hauling trains moving without causing congestion on the mainline.

Up for sale is a brand new and never been used SuperScale Live Steam Nathan Boiler Check Valve.

These NATHAN BOILER CHECK VALVES feature the a shut-off valve assembly. The shut-off valve is functional allowing removal of the internal check poppet while the boiler is under steam. When piping this valve, it is recommended to use 5/16" copper tubing soldered into the inlet coupling. The mounting thread on the back side of the flange is male 1/8 NPT.

The valves are reversible for either side of the boiler. The mounting flange diameter is 1". The center of the outlet to the bottom of the inlet tailpiece is 1.31". Part number 14-05.

Up for sale is a brand new and never been used SuperScale Live Steam Hancock Boiler Check Valve.

These HANCOCK BOILER CHECK VALVES have different inlet pipe designs than on a common body, and use 3/8" tube for the inlet piping. Operable either vertically or horizontally, they mount to the boiler with a 1/8 NPT thread. They have a larger capacity than the NATHAN valves. The mounting flange diameter is 1". Part number 14-09.
